As many of you are aware, the lawyers at Levin & Perconti have successfully represented clients in many different areas of personal injury practice including medical malpractice, nursing home negligence, premises liability, slip and fall accidents, and construction accidents. We are writing this month to let you know that in addition to these practice areas, we have successfully represented numerous clients who have been victims of automobile accidents, trucking accidents, and pedestrian accidents. Some of our verdicts and settlements in these areas include the following:

**\$10 million settlement** for a 5-year-old boy who was run over by a City of Chicago Fire Department truck while playing near an open fire hydrant on the Fourth of July, resulting in the loss of his leg and half of his pelvis.

**\$2.07 million verdict** for a 23-year-old woman who suffered multiple leg fractures in an automobile collision.

**\$1.25 million settlement** for a 77-year-old woman whose right leg was amputated above the knee after she was struck by a bus while walking in a bus terminal.

**\$1.25 million settlement** for a 50-year-old woman who suffered multiple pelvic fractures, rib fractures, and spinal transverse process fractures when she was run over by a bus while walking in a crosswalk.

**\$820,000 settlement** for a 33-year-old plaintiff who was a passenger in a car that was hit by another car. The plaintiff suffered extensive injuries to her arm, requiring multiple orthopedic and plastic surgeries.

In the event you or someone you know is involved in any type of car, truck, or pedestrian accident, we recommend that you call the police first. Be sure to let them know if you have suffered any injuries so that they can take steps to get you the appropriate medical attention. If you are able to, obtain the other driver's name, phone number, date of birth, driver's license number, license plate number, and insurance information.

If you are injured in an accident due to the negligence of someone else, you may be entitled to compensation for your injuries. Please don't hesitate to contact us, as we would be happy to discuss your situation.
